

## INVEON BİLGİ TEKNOLOJİLERİ DANIŞMANLIK VE TİCARET ANONİM ŞİRKETİ APPLICATION FORM REGARDING PERSONAL DATA PROTECTION

In accordance with article 11 of the Law on the Protection of Personal Data No. 6698 ("KVKK") and the applicable law, personal data subjects "Applicant" have the right to request to be informed through written application to be referred to the data controller INVEON BİLGİ TEKNOLOJİLERİ DANIŞMANLIK VE TİCARET ANONİM ŞİRKETİ ("Inveon").

By means of this Application Form you have the right to;

- a) Learn whether your personal data is processed or not,
- b) Request information as to personal data if it has been processed,
- c) Learn the purpose of processing and whether the data is used in accordance with its purpose,
- d) Learn the third parties that personal data has been transferred to, in the country and abroad,,
- e) Request rectification if the data have been processed incompletely / inaccurately,
- f) Request deletion or destruction of personal data that is processed by operation of KVKK and other relevant law, if causes of processing ceased to exist,
- g) Request notification of the operations made as per indents (e) and (f) to third parties to whom personal data has been transferred,
- h) Object to occurrence of any result that is to her/his detriment by means of analysis of personal data exclusively through automated systems,
- i) Request compensation for the damages in case the person incurs damages due to unlawful processing of personal data.

As to the rights mentioned above and article 11 of KVKK, you may file your application of request by sending this application in "written" form to Inveon located at Nispetiye Mahallesi Nispetiye Caddesi No:24/18 Beşiktaş - İstanbul in person, through a notary public, via registered and reply-paid letter or by sending an e-mail to [info@inveon.com](mailto:info@inveon.com). "Information Request egarding Personal Data Protection" should be written on the subject line of the e-mail, and on the envelope, according to the application method.

Your requests will be concluded free of charge and within thirty days at the latest in accordance with paragraph 2 of article 13 in the KVKK. However, if the transaction requires a cost, a fee may be charged according to determined rates by the Board of Protection of Personal Data.

The reply shall be informed in written form or electronically in accordance with article 13 of KVKK.
